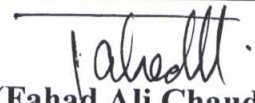
SALES TAX GENERAL ORDER NO. 29 OF 2013

Subject: **AMENDMENT IN STGO 10/2007 DATED 13-09-2007 – WITHDRAWAL OF FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY**

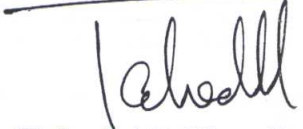
