Subject: **AMENDMENT IN STGO 07/2007 DATED 13-09-2007- ALLOWING / WITHDRAWAL FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY.**

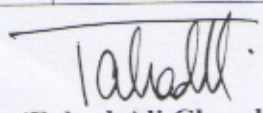
In the aforesaid General Order, in the Table —,

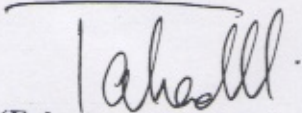
