

The first quarter of Financial year 2013-14 is closing on 30th September, 2013. Traditionally bulk of revenue is collected during the last one or two days. To avoid the difficulties of the taxpayers in depositing the duties / taxes, the State Bank of Pakistan and the National Bank of Pakistan on our request have always cooperated by extending their working hours.

2. In order to facilitate the taxpayers, it is requested that instructions may kindly be issued to all the branches of State Bank of Pakistan, the authorized branches of National Bank of Pakistan and National Institute of Facilitation Technologies (NIFT), to remain open on Saturday 28th September, 2013 from 09:00 AM to 05:00 PM and to extend the closing time on Monday 30th September, 2013 to 08:00 PM. Arrangements may also kindly be made to ensure that the collection in branches of National Bank of Pakistan upto 30th September, 2013 is transferred to the State Bank of Pakistan by 30th September, 2013 and reported accordingly.

3. If possible, additional counters may also be arranged.
