**SUBJECT: RESTRICTIONS ON INFORMATION SYSTEMS USAGE DURING FEDERAL BUDGET 2014-15.**

Due to Budget announcement on 3<sup>rd</sup> June, 2014 restrictions on access to servers / information systems running at FBR (HQ) will remain in force from 4.00 p.m. on the 1<sup>st</sup> of June, 2014 till the end of budget speech on the 3<sup>rd</sup> of June, 2014 as per following details:-

Sr.	Systems	Details
1	e-Dox	<ul style="list-style-type: none"> <li>a. Message and Engagement features will be disabled and would not be accessible for the internal users of FBR House.</li> <li>b. Users located in the FBR house premises would only be limited in routing/marketing their correspondence in the wings located within FBR House premises. No one within FBR (HQ) will be allowed to mark/route and file/document to FBR wings/offices outside FBR (HQ) premises. However, external users such as RTOs/LTUs/MCCs would be able to mark their correspondence to the internal users/wings of FBR.</li> <li>c. All training versions of the e-dox system would be inaccessible during the budget days.</li> <li>d. Help desk for e-Dox will be closed.</li> </ul>
2	HRIS	<ul style="list-style-type: none"> <li>a. Access to the system for correction of disposition lists, online application of leave and other facilities will be completely banned for filed formations.</li> <li>b. Help desk for HRIS will be closed.</li> </ul>
3	e-FBR Portal	<ul style="list-style-type: none"> <li>a. FBR portal/Server will remain accessible for authorized users outside FBR (HQ) premises but no one within FBR (HQ) will be allowed to access e-FBR portal during Budget Exercise.</li> </ul>
4	STARR & SALES TAX SYSTEMS	<ul style="list-style-type: none"> <li>a. STARR &amp; SALES TAX Systems / Server will remain inaccessible for FBR (HQ) users; however, authorized users/outside FBR (HQ) premises will be allowed to access the system/Server.</li> </ul>

5	PRAL & FBR Network & Internal	<p>a. While the local networks of PRAL (HQ)/CDA Block 2 offices and FBR (HQ) will remain operational individually, transfer of any files/document from FBR (HQ) Network to PRAL (HQ)/CDA Block 2 offices Network and vice versa will be banned.</p> <p>b. <b>Internet service will remain unavailable in FBR (HQ) till conclusion of Budget Speech by the Finance Minister.</b></p>
