

Please find enclosed herewith letters No. FD.GOV/653/87-2014 and FD.GOV/662/87- 2014 dated 25.06.2014 issued by the State Bank of Pakistan in which following instructions for the opening of banks have been issued:-

<b>State Bank of Pakistan</b>	30 <sup>th</sup> June, 2014 till 10:00 pm
<b>National Bank of Pakistan</b>	28 <sup>th</sup> and 29 <sup>th</sup> June, 2014 till 8:00 pm and on 30 <sup>th</sup> June, 2014 till 12:00 midnight
<b>Commercial Banks</b>	28 <sup>th</sup> June (normal working hours) and 30 <sup>th</sup> June, 2014 until 10.00 p.m.
<b>NIFT</b>	Will remain available to collect and sort the clearing instruments deposited on 28 <sup>th</sup> & 29 <sup>th</sup> June, 2014 from NBP. Two special clearings on 30 <sup>th</sup> June, 2014 at 3:00 pm and 10:00 pm respectively have also been arranged besides normal clearings.

2. It is further informed that all Model Customs Collectorates will remain open on **28<sup>th</sup> & 29<sup>th</sup> June, 2014** till 8:00 pm and on **30<sup>th</sup> June, 2014** until 12:00 midnight. Chief Collectors are requested to establish liaison with State Bank of Pakistan and authorized branches of National Bank of Pakistan to ensure transfer of duty/taxes collection by the these branches before or on 30.06.2014 on the same date to account for this collection for the month of June, 2014. All Chief Collectors should personally ensure that all transactions relating to 30<sup>th</sup> June 2014 and before are settled before the close of current financial year. Any lapse on this account will be viewed seriously.
