In partial modification to Jurisdiction Order No. 8693, dated, 09.04.2014 and in exercise of the powers conferred by of section 210(1) of the Income Tax Ordinance, 2001, section 32(1) of Sales Tax Act, 1990 and Rules, section 29(4) of Federal Excise Act, 2005 and Rules and section 10(1) of the Wealth Tax Act, 1963 (repealed) and in pursuance of Federal Board of Revenue Notifications No. 57(2)S-DOS/2011 dated 26-02-2011 and No. 0485-IR-I/2011 dated 07-03-2011, and in supersession of all the earlier Orders or Notifications, the undersigned is pleased to direct Officers Inland Revenue specified in Column-II, that they shall exercise all the powers and perform the functions conferred upon or assigned to me under the said laws as specified in Column-III, in respect of the persons or classes of persons or cases or classes of cases or areas as specified in Column (IV) of the Table below (excluding cases or classes of cases or persons or classes of persons assigned to other RTOs/LTUs) as well as powers and functions not delegated in Column-V.

This notification shall take effect from Aug 22, 2014.
