(Inland Revenue Wing, FBR)

Subject: - **JURISDICTION OF COMMISSIONERS INLAND REVENUE, RTO-III, KARACHI**

In exercise of the powers conferred under sub-section (1) of section 209 of the Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005, the Federal Board of Revenue is pleased to direct that following amendments / modifications shall be made in Board's Notification C.No.57(2)Jurisdiction/2011-Vol-V/2187-R dated 31.12.2012, with immediate effect and until further orders:

1. Against serial no.01, in column (4),-
 - i) clause I shall be substituted as under:

“I. Educational Institutions/ tuitions centers excluding educational institutions approved u/s. 2 (36) of the Income Tax Ordinance, 2001”;
 - ii) clause II shall be substituted as under:

“ II. manufacturers, importers, exporters and wholesalers of tea; artists including musicians, dancers, singers, public entertainers or film, stage, radio, t.v artists; manufacturers, importers, exporters, wholesalers of sugar; and manufacturers, importers, exporters and wholesalers of canvas & tents”;
 - iii) clause III shall be substituted as under:

“III. All cases of companies (other than cases assigned to any other LTU/RTO/Zone), whose names begin with alphabets Q, R & T”;
 - iv) clause VI shall be substituted as under:

“VI. All employees of federal government, provincial government, regulatory authorities, development authorities, government companies, government corporations, commissions, boards and local government, posted in the civil division of Karachi”.
2. Against serial no.02, in column (4),-
 - i) clause I shall be substituted as under:

“I. All private sector employees including doctors”.

ii) clause III shall be substituted as under:

“III. Recreation clubs, farm houses; and rice processors, importers, exporters and wholesalers”.

3. Against serial no.03, in column (4),-

i) clause I shall be substituted as under:

“I. All sorts of plastics, polythene manufacturers including packaging made from plastics; printing on plastic packaging; and pipe manufacturers including dealers/wholesalers/retailers/distributors/importers/ exporters related to the entire sector”.

ii) clause II, III & IV shall be omitted;

iii) clause VI shall be substituted as under:

“VI. All cases of companies (other than cases assigned to any other LTU/RTO/Zone), whose names begin with alphabets U, V & W”.

4. Against serial no. (04), in column (4),-

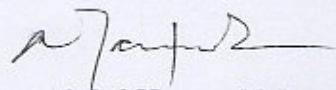
i) clause I shall be substituted as under:

“I. All cases of airlines, operation of air transport, leasing of aircrafts, shipping/ shipping agents and maritime transport operation of ships and owners and charterer of ships”.

ii) in clause II, after the words “Stevedores”, the words “Transporters/Transport services” shall be added;

iii) in clause III after the words “Ship Breaking”, the words “including ship breakers engaged in steel melting/steel re-rolling” shall be added;

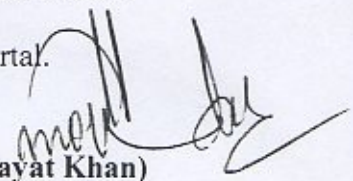
iv) clause IV shall be omitted.
