SALES TAX GENERAL ORDER NO. 35 OF 2015

Subject: **AMENDMENT IN STGO 07/2007 DATED 13-09-2007- WITHDRAWAL FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY.**

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, read with SRO. 1125(I)/2011 dated 31.12.2011, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 07 of 2007 dated 13th September, 2007, namely:-

In the aforesaid General Order, in the Table,

- (a) against serial number **27**, in column (1), the figure "**BL 002310**", appearing in column (4) shall be **omitted**;
- (b) against serial number **117**, in column (1), the figure "**AP 087002**", appearing in column (4) shall be **omitted**;
- (c) following serial numbers, in column (1) and entries relating thereto in columns (2), (3) and (4) shall be **omitted**.
