**COLLECTION OF DUTY/TAXES ON 29TH AND 30TH JUNE, 2015 BY
AUTHORIZED BRANCHES OF SBP, NBP, COMMERCIAL BANKS AND NIFT**

This is with reference to the FBR letter D.O. No. 1(8) Rev.Bud/2014 dated 19th June, 2015 (copy enclosed) on the above subject and SBP's subsequent instructions issued, vide letter No.FD.GOVVT/1140/87-2013 dated November 28, 2013.

In this regard, it is advised to ensure compliance of the following operational instructions for 29th & 30th June 2015 with regard to settlement/ clearing of FBR transactions on month end.

- To keep authorized NBP branches (A, B & C) open till 8:00 pm on 29 June 2015 (Monday) for collection of FBR taxes/duties and till 08:00 pm for cheque collection and 10:00 pm for cash counters on 30th June 2015 (Tuesday) for government receipts & payments.
- The NBP branches (A, B & C) will settle their transactions on same day i.e. 30th June 2015 with respective SBP BSC Offices for which two special clearings will be arranged i.e. 1st & 2nd clearing immediately after 3:00 p.m. and 10:00 p.m.
- Further, to facilitate tax payers, the NBP branches (A, B & C) will accept cash transactions at their counters till 10:00 pm on 30th June, 2015.

Please ensure meticulous compliance of the above.
