NOTIFICATION

(Inland Revenue Wing, FBR)

Subject: - **JURISDICTION OF CHIEF COMMISSIONER AND COMMISSIONERS INLAND REVENUE, LARGE TAXPAYER UNIT-II, KARACHI.**

In exercise of the powers conferred under sub-section (1) of section 209 of the Income Tax Ordinance, 2001 (hereinafter read as 'Ordinance'), sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005, Karachi, the Federal Board of Revenue is pleased to direct that:

- i) the Chief Commissioner of Inland Revenue, LTU-II, Karachi, shall exercise the powers and perform functions under the Income Tax Ordinance, 2001, the Sales Tax Act, 1990, the Federal Excise Act, 2005, section 7 of the Finance Act, 1989 (V of 1989) and sub-section (1) of section 10 of Wealth Tax Act, 1963 (Repealed), in respect of the persons or cases mentioned in the Schedules I, II, III, IV, as annexed to this notification; and
- ii) the Commissioners of Inland Revenue specified in column (2), shall exercise the powers and functions, as specified in column (3), in respect of the persons or cases as specified in column (4) of the Table below.

2. This notification shall take effect from 1st February, 2016.

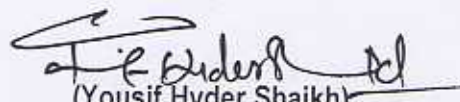

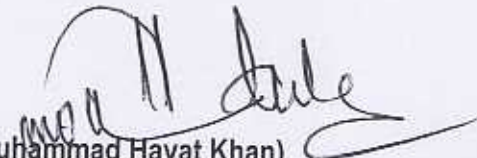
