TIMELY REPORTING & DEPOSIT OF GOVERNMENT RECEIPTS/ PAYMENTS BY NATIONAL BANK OF PAKISTAN

September 16, 2013

A meeting was held in the Conference Room of Ministry of Finance (Q- Block, Pak Secretariat, Islamabad) on 18th September 2013 chaired by Secretary Finance to discuss the issues of timely report and deposit of Government receipts/payments by National Bank of Pakistan.
