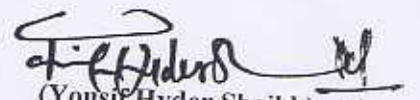

Workers Welfare Fund Ordinance, 1971.	2) All cases of persons and director thereof mentioned in schedule 3A which is part and parcel of this notification.

2. This order shall take effect from 1st of August, 2016.

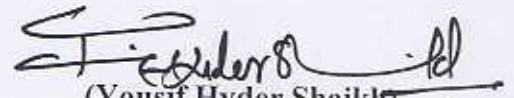
