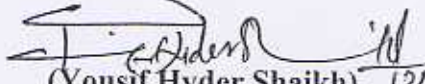

**SUBJECT: JURISDICTION OF CHIEF COMMISSIONER AND COMMISSIONERS
INLAND REVENUE, CORPORATE REGIONAL TAX OFFICE,
KARACHI.**

In exercise of the powers conferred by section 209 of the Income Tax Ordinance, 2001 (hereinafter read as Ordinance) section 30 and section 31 of the Sales Tax Act 1990, section 29 of the Federal Excise Act 2005, and in partial modification to Notification issued vide F.No.57(2)Jurisdiction/2016-95904-R dated 21st July 2016, the Federal Board of Revenue is pleased to direct the following amendments:

- I. In S.No. 01 in column (4) in clause (a) after sub-clause (iv) following shall be added:-
 - (v) Manufacturer, importer and exporter of chemicals and chemical Products;
 - (vi) Any other sector of Companies not assigned to LTU/LTU-II Karachi or any other zone of Corporate RTO, Karachi whose name begins with alphabet "T", and ; after clause (c) sub-clause (i) following shall be added:-
 - (ii) All Cases of all Non-Profit Organizations /Charitable Institutions;
 - II. In S.No. 02 in column (4) in clause (a) after sub-clause (v) following shall be added:-
 - (vi) Any other sector of Companies not assigned to LTU/LTU-II Karachi or any other zone of Corporate RTO, Karachi whose name begins with alphabet "F to K"
 - III. In S.No. 03 in column (4) in clause (a) sub-clause (v) shall be read as :-
 - (v) Any other sector of Companies not assigned to LTU/LTU-II Karachi or any other zone of Corporate RTO, Karachi whose name begins with alphabet "A to E"
 - IV. In S.No. 04 in column (4) clause (b) shall be read as :-
 - (b) Any other sector of Companies not assigned to LTU/LTU-II Karachi or any other zone of Corporate RTO, Karachi whose name begins with alphabet "L & M"
 - V. In S.No. 05 in column (4) clause (a) sub-clause (i) shall be deleted and clause (b) shall read as :-
 - (b) Any other sector of Companies not assigned to LTU/LTU-II Karachi or any other zone of Corporate RTO, Karachi whose name begins with alphabet "N to S & U to Z"
2. This notification shall take immediate effect.
