The undersigned is directed to refer your request dated Nil for reconsideration of the decision of the Honorable President of Pakistan on the subject noted above.

2. The matter has been examined in this Secretariat. It is to inform that the particular representation dated 18.05.2017 was filed by Agency-FBR against the findings of FTO dated 25.4.2017 whereby it was recommended that:

"FBR to direct the:-

- (i) Chief Commissioner, RTO-II, Lahore to register the Complainant immediately; and
- (ii) Report compliance within 45 days."

3. On the said representation the appellate forum was pleased to pass the following orders:-

"The President has been pleased to accept the instant representation of the Agency-FBR and to set aside the impugned recommendations/findings of FTO".

Accordingly, President's Secretariat (Public) vide letter dated 07.08.2017 had already communicated the decision of the hon'ble President of Pakistan to all the stakeholders including the complainant. The complainant has again requested that the appellate forum may reconsider/ review of the President's Order dated 07.08.2017.

5. It may be mentioned that there is no provision under Federal Ombudsmen Institutional Reforms Act, 2013 for review of the President's decision passed on any representation. In absence of any statutory provision for review of the President's order without any solid legal ground(s), the instant representation for review of the earlier Presidential decision cannot be entertained.
