CORRIGENDUM
(Inland Revenue Operations Wing, FBR)

Subject: - AMENDMENT TO THE JURISDICTION OF CHIEF COMMISSIONER AND COMMISSIONERS INLAND REVENUE, REGIONAL TAX OFFICE (RTO), ISLAMABAD

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, and sub-section (1) of section 29 of the Federal Excise Act, 2005, and section 3 of the Islamabad Capital Territory (Tax on Services) Ordinance, 2001, the Federal Board of Revenue is pleased to rectify the Board's Jurisdiction Notification F.No.57(2)Jurisdiction/2017-113471-R dated 19th September, 2017, in the following manner:

- I. At S.No. 01. of the table; in column (4), in sub-para (d) the words "individuals, AOPs and" shall be omitted;
- II. At S.No. 02. of the table; in column (4) the following Para shall be added:

"d) all non-corporate cases of persons/classes of persons not otherwise specifically assigned, lying within the territorial limits of the Islamabad Capital Territory and falling on the **East** of the Faisal Avenue starting at the Faisal Mosque, and Islamabad Expressway ending at Rawat, predominantly providing or rendering services subject to Sales Tax under the Islamabad Capital Territory (Tax on Services) Ordinance, 2001 (as amended from time to time).";
- III. At S.No. 03. of the table; in column (4) the following Para shall be added:

"d) all non-corporate cases of persons/classes of persons not otherwise specifically assigned, lying within the territorial limits of the Islamabad Capital Territory and falling on the **West** of the Faisal Avenue starting at the Faisal Mosque, and Islamabad Expressway ending at Rawat,

predominantly providing or rendering services subject to Sales Tax under the Islamabad Capital Territory (Tax on Services) Ordinance, 2001 (as amended from time to time).”
