NATIONAL BANK OF PAKISTAN ON 29TH and 30TH JUNE, 2017

- All the authorized NBP branches (A, B & C) shall remain open till 12:00 a.m. (midnight) on 29th & 30th June 2017 (Thursday & Friday) for collection of government receipts only, whether federal or provincial.
- The NBP branches will settle their transactions of 30th June 2017 on same day with respective SBP (BSC) offices for which two sessions for special clearing will be arranged i.e. 1st and 2nd clearing immediately after 03:00 p.m. and 12:00 a.m. (midnight) respectively.

Please ensure the meticulous compliance of the above.
