## COLLECTION OF DUTIES & TAXES BY NBP ON 29th & 30th September, 2018

In pursuance of the request of Federal Board of Revenue (FBR), following instructions regarding Government banking business on September 29 & 30, 2018 may please be complied with.

- . On September 29, 2018 (Saturday): NBP branches (A.B & C). as well as field offices of the SBP Banking Services Corporation (BSC), shall accept banking instruments and cash at their counter up to 06:00 PM. A Special Clearing shall be arranged by the NIFT at 04:00 PM.
- On September 30, 2018 (Sunday): NBP branches (A,B & C), as well as field offices of the ii. SBP Hanking Services Corporation, shall remain open only for collection of FBR taxes / Government receipts up to 08:00 PM. A Special Clearing shall be arranged by the NIFT at 06:00 PM and NBP shall settle the transactions with SBP BSC field offices / head office till 10:00 PM same day i.e. September 30, 2018.

It is clarified, that on both days above, NBP / BSC field offices shall NOT execute any payment out of Government accounts except such payments as they relate to payment of FBR taxes and duties out of one Government account to another Government account.

Please ensure the meticulous compliance of the above.
