In exercise of powers conferred under Rule 3 of the *Benami* Transactions (Prohibition) Rules, 2019 and section 15 of the *Benami* Transactions (Prohibition) Act, 2017, the Federal Board of Revenue is pleased to direct that the Commissioners Inland Revenue, Deputy Commissioners Inland Revenue and Assistant Commissioners Inland Revenue specified in column (2) shall exercise the powers and perform the functions of the "Authorities" under the provisions of *Benami* Transactions (Prohibition) Act, 2017 as specified in column (3), in respect of territorial areas as specified in column (4) of the Table below:

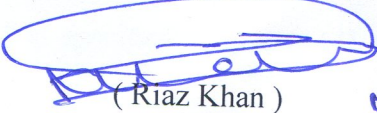

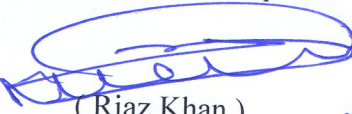
