COLLECTION OF DUTIES & TAXES BY NBP ON 30TH SEPTEMBER, 2019

Pursuant to FBR's request for opening of banks' branches and extension in banking hours on 30th September 2019, following instructions regarding observance of banking hours are being issued for compliance to facilitate the taxpayers:

- i. The NBP branches (A,B & C), as well as field offices of the SBP Banking Services Corporation, shall observe extended banking hours up to **09:00 PM on 30th September 2019.**
- ii. The NBP branches (A, B & C) will settle their transactions on same day i.e. **30th September, 2019** with respective SBP-BSC Offices for which purpose a special clearing will be arranged at **7:00 PM by the NIFT on 30th September, 2019**
- iii. The NBP shall settle their cash transactions with SBP-BSC field offices / head office latest by 11:00 PM on 30th September, 2019.

Further, in order to eliminate the issue of spillover receipts, NBP shall ensure that no instrument containing receipts of Govt. shall remain unattended at any NBP branch and shall be settled in the value date of 30th September 2019 through special clearing.

Please ensure the meticulous compliance of the above.
