Subject: - Jurisdiction of the Chief Commissioner and Commissioners Inland Revenue, Large Taxpayers' Office, Multan.

In exercise of the powers conferred under section 209 of Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005, read with the Islamabad Capital Territory (Tax on Services) Ordinance, 2001, the Federal Board of Revenue is pleased to:

- (i) Direct that the Chief Commissioner Inland Revenue, Large Taxpayers' Office, Multan shall exercise the powers and perform functions under the Income Tax Ordinance, 2001, the Sales Tax Act, 1990, and the Federal Excise Act, 2005 in respect of persons mentioned in Table-B and Table-C.
 - (ii) Assign to the Commissioners Inland Revenue as mentioned in column 2 of the following Table A jurisdiction, powers and functions as specified in column 3 of the said Table A in respect of the persons and cases as mentioned in column 4 of the said Table A.
2. This order shall take effect from 15th of October, 2020.
