**COLLECTION OF DUTIES & TAXES BY NBP ON 29<sup>TH</sup> AND 30<sup>TH</sup> JUNE, 2020**

Pursuant to FBR's request for opening of banks' branches and extension in banking hours on 29<sup>th</sup> and 30<sup>th</sup> June 2020, following instructions, regarding observance of banking hours on 29<sup>th</sup> & 30<sup>th</sup> June 2020 are issued for compliance to facilitate the taxpayers:

- i. The NBP branches (A,B & C), as well as field offices of the SBP Banking Services Corporation, shall observe extended banking hours up to 08:00 PM on 29<sup>th</sup> June 2020.
- ii. On **June 30<sup>th</sup>, 2020**, the authorized NBP branches (A, B & C) and SBP BSC field offices shall remain open till 07:00 p.m. for cheques collection and 10:00 p.m. for cash counters on 30<sup>th</sup> June, 2020 (Tuesday), for which purpose a special clearing will be arranged at 07:00 PM by the NIFT on 30<sup>th</sup> June, 2020.
- iii. The NBP shall settle their 30<sup>th</sup> June, transactions with SBP-BSC field offices / head office latest by 11:00 AM next day i.e. 1<sup>st</sup> July, 2020.

Further, in order to eliminate the issue of spillover receipts, NBP shall ensure that no instrument concerning government receipts, lodged in aforesaid office hours, shall remain unattended at any NBP branch and shall be settled in the value date of 30<sup>th</sup> June, 2020 through special clearing.


