ORDER

**Subject: JURISDICTION OF THE CHIEF COMMISSIONER INLAND REVENUE
AND COMMISSIONERS INSLAND REVENUE AT LARGE
TAXPAYERS' UNIT, ISLAMABAD.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005 read with the Islamabad Capital Territory (Tax On Services) Ordinance 2001 and in suppression of all previous orders issued under the aforementioned legal provisions in respect of jurisdiction, functions and cases assigned to LTU Islamabad, the Federal Board of Revenue is pleased to:-

- i. Direct that the Chief Commissioner Inland Revenue, LTU Islamabad shall exercise the powers and perform functions under the Income Tax Ordinance, 2001, the Sales Tax Act, 1990, and the Federal Excise Act, 2005 in respect of persons mentioned in TABLE-B and TABLE-C;
- ii. Re-designate the Commissioners Inland Revenue as mentioned in column No-2 of the following Table A as the Commissioners Inland Revenue as mentioned in column No-3 of the said Table A; and
- iii. Assign to the Commissioners Inland Revenue as mentioned in column No-3 of the following Table-A jurisdiction, powers and functions as specified in column No-4 of the said Table A in respect of the persons and cases as specified in column No-5 of the said Table A.

2. This order shall take effect from the 10th of August, 2020.

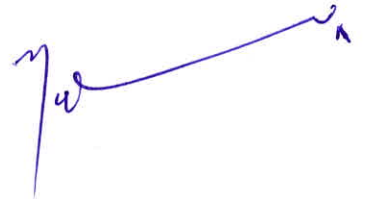
