OFFICE MEMORANDUM

Subject: - REQUISITION OF OFFICERS ON DEPUTATION IN EOBI FROM THE FEDERAL GOVERNMENT

The undersigned is directed to refer to the subject cited above and to state that the Employees' Old-Age Benefits Institution (EOBI) is an autonomous body working under the administrative control of this Ministry. The Institution is facing drastic shortage of officers and the management has informed that the post of Investment Advisor/ DG (Investment), DG, Operations (South) are vacant for last one and two years respectively, and that the post of DG, Operations (North) is also likely to be vacant. These positions are of the key significance to run the affairs of the Institution, without which the operations and investment decision would harm the pension disbursements and contribution collection of the Institution.

2. Establishment Division is, therefore, requested to urgently depute suitable officers of BS-20 at the disposal of EOBI, on deputation for a period of three years on standards terms and conditions on following positions:-

- i. Director General, Operations (North)
- ii. Director General, Operations (South)
- iii. Director General, Investment
