

**OPENING OF SBP-BSC OFFICES AND NBP BRANCHES FOR COLLECTION OF DUTIES  
AND TAXES ON SATURDAY THE 27<sup>TH</sup> FEBRUARY 2021 and ILink ADC settlement**

Pursuant to FBR's request for opening of SBP-BSC offices and NBP branches on Saturday the 27<sup>th</sup> February 2021, for collection of government duties and taxes, following instructions regarding settlement and observance of banking hours on 27<sup>th</sup> February 2021, are issued for compliance:

1. The SBP-BSC offices and NBP branches (A, B and C category) shall observe **Saturday the 27<sup>th</sup> February 2021, as normal working day till 06.00 p.m.** for collection of government duties and taxes only.
2. The cash receipts at NBP's branches (A, B and C category), collected till 06.00 p.m. on Saturday the 27<sup>th</sup> February 2021, shall be settled with the SBP-BSC offices by 07:00 p.m sharp.
3. In order to ensure same day settlement of duties and taxes collected through ADC mode, M/s ILink shall provide the settlement batch of ADC transactions, executed till 07:00 PM on 27<sup>th</sup> February 2021, to the SBP-BSC Karachi Office for settlement.
