Entry into Force and Entry into Effect of Multilateral Convention to Implement Tax Treaty Related Measures to Prevent Base Erosion and Profit Shifting (the MLI) for Pakistan

I am directed to refer to the subject and to state that Pakistan signed and ratified the MLI on 07.06.2017 and 18.12.2020 respectively. - 2. Pakistan had entered into 66 DTAs. Till now, out of 66, only 26 treaty partners of Pakistan have ratified MLI and have included Pakistan in their lists of Covered Tax Agreements (CTAs) as per Article 2 of the MLI. This Directorate has synthesized DTAs incorporating the relevant provisions of MLI which are being sent to treaty partners for input. After obtaining their input, the same will be uploaded on FBR's website.
- 3. I am further directed to say that as on today, the dates of entry into force and entry into effect of MLI for Pakistan viz-z-viz its treaty partners (who have ratified the MLI and who have furnished dates of entry into force and entry into effect) are reflected as under for ready reference:
