2. Your input/suggestions in the following policy areas shall be highly appreciated:-


- (i) Broadening of tax base for a wider participation in revenue generation efforts;

- (iii) Phasing out of tax concessions and exemptions;
- (iv) Removal of tax distortions and anomalies;
- (v) Facilitation of taxpayers and ease of doing business;
- (vi) Promoting equity in taxation by introducing measures where incidence of tax is higher on affluent classes.

The areas identified above are just illustrative and not exhaustive.
