## MEMORANDUM OF UNDERSTANDING

### Federal Board of Revenue (FBR)

#### Subject: Lab Agreement.

This Understanding is made on 13<sup>th</sup> April, 2022 between Pure Health Lab Islamabad having its registered office at and hereinafter referred to as the Diagnostic Center which expression shall include its representatives, successors –in-interest and assigns of the one part.

And

Federal Board of Revenue” having its Office on Shahrah-e-Dastoor, Islamabad of the other part.  
Whereas: the Diagnostic Center agrees to provide medical services to the FBR for medical treatment of persons pertaining to FBR.

1. And whereas: the FBR agrees to avail of such services.

2. **Terms of the MoU:**

2.1. Entry into force and Termination;

2.2 This Understanding shall remain valid from the date of signing. It will be valid and affective from the date of signing and may be discontinued by either party by giving one month’s written notice to the other party through the post or by hand delivery.

3. **Responsibilities of Diagnostic Center:**

3.1. The types of medical services which the Diagnostic Center can provide relating to out- patient services have been advised to the FBR by the Diagnostic Center along with the discounted charges of such medical services which will be paid by the FBR employees in cash on the spot. The agreed discounted rates will be valid initially for a period of three (03) years commencing from the Signing Date and thereafter the same may be revised with mutual agreement between the Parties for subsequent period.

3.2. That the Pure Health Laboratory will provide “Medical & Diagnostic Services” to M/s FBR with the following discount percentages on the rates provided vide list as “Annex-A”;

- 3.3. Diagnostic Center will issue cards for each employee of FBR as provided by FBR. Agreed discount mentioned on this card will be provided by Diagnostic Center.
- 3.4. CT Scan and MRI Facility will be arranged in some other premises by Pure Health Lab with 25% discount. Patient will go for test on transport of Pure Health Lab.
- 3.5. There will be no hidden charges in agreed rates.
- 3.6. FBR Employees/Dependents will get priority services from Pure Health lab.
- 3.7. If treating doctor (of concerned patient) raises any objection/doubt about results of the test then this test will be repeated by Pure Health Lab free of cost.
- 3.8. Collection point details of Pure Health lab will be provided in hard and soft form to FBR Management.
- 3.9. Reports will also be available on Email/WhatsApp.
- 3.10. Special discount will be provided to frequent visitor/ 60 plus aged persons/and Lower Staff (up to Class 4) by Pure Health Lab.

#### 4. Responsibilities of FBR:

- 4.1. FBR shall not be responsible for financial liability of any employee towards Pure Health Laboratory nor shall reimburse any expenditure of any of its employee. All FBR's employees visiting Pure Health Laboratory will be personally liable for any payment towards Pure Health Laboratory and shall pay it in cash.
- 4.2. FBR will provide list of those FBR employees to Pure Health Laboratory who intends to avail the subject services.

#### 5. Miscellaneous Provisions:

- 5.1. In case any dispute arises between the parties to this MoU, the dispute will be settled mutually between Senior Management of Pure Health Laboratory and FBR. No case will be referred to any court of Law by both parties.
