I am directed to refer to Board's letter of even number dated 05.01.2022 and subsequent reminders dated 31.01.2022, 26.04.2022 and 13.06.2022 on the subject matter and to state that information on the prescribed format (**copy enclosed**) in respect of all Cadre / Ex-Cadre / Regular / Contract officers of FBR including officers on deputation (BS-17 & above) and their spouses was sought. However, information from most of the office(s)/field formation(s) and BS-17 & above officers of FBR presently on deputation / leave is still awaited. A list in this regard is attached as (**Annex-I**).


2. The non-provision of the subject information within the stipulated time has resulted in an Appeal No. 1690-01/2022 by Rana Abrar Khalid before the Pakistan Information Commission who vide order dated 15.06.2022 directed FBR to provide all the requested information within seven days of the receipt of the order.

3. It is again stated that to comply the orders of Honourable Pakistan Information Commission the information in respect of all BS-17 & above officer(s) of all cadres of FBR either regular, contractual or deputationist must reach the Board by today i.e. **07.07.2022**.

In view of above, the all Heads of field formations (as per list at **Annex-I**) are requested to provide the information on prescribed format in respect of officer(s) under their administrative control by return of fax on **051-9205407** or email at **sec.mgt.ir1@fbr.gov.pk**. The officer(s) who are presently on deputation / leave are required to send their information directly to the Board.
