# OBSERVANCE & IMPLEMENTATION OF 2% DISABILITY QUOTA

I am directed to refer and forward a copy of Establishment Division's O.M. No. 34/3/86-R-V dated 23.12.2022 on the subject cited above and to convey the following directions for strict compliance by all Heads of Customs Field Formations of FBR:-

- i) HR Plan for recruitment against prescribed Disability Quota including total sanctioned strength, quota against disability already filled, any shortfall in observance of Disability Quota and the time frame in which the shortfall shall be filled by each office, should reach the Board latest by 20<sup>th</sup> January, 2023 positively, so that consolidated HR Plan could be placed on the website of FBR latest by 30<sup>th</sup> January, 2023, as per sub-para (iii) of the above referred O.M. of the Establishment Division.
- ii) 1<sup>st</sup> quarterly report should be submitted latest by 10<sup>th</sup> April, 2023 positively, so that consolidated quarterly report may be furnished to the Establishment Division latest by 15<sup>th</sup> April, 2023, in compliance of sub-Para (i) of the above referred O.M. of the Establishment Division.

OBSERVANCE & IMPLEMENTATION OF 2% DISABILITY QUOTA

In continuation to this Division's earlier O.M of even number dated 25<sup>th</sup>. November, 2022, on the subject, it is stated that in compliance to the Islamabad High Court's order in the matter, a meeting was convened on 14.12.2022 under the Chairmanship of Special Secretary, Establishment Division. The following decisions were taken in the meeting:

2 9 DEC 2022 AA

The Ministries/Divisions to regularly send quarterly reports to PPARC, Establishment Division providing the updated status of the observance of 2% disability quota. The 1<sup>st</sup> quarterly report should be submitted by 15<sup>th</sup> April, 2023 for the period of January – March, 2023.

- A representative from Council on Rights on Persons with Disabilities (CRPD), Ministry of Human Rights to be included as co-opted member in the selection/recruitment committee for all recruitments against Disability Quota.
- iii. The Ministries / Divisions to post the HR Plan for recruitment against Disability Quota on their respective websites by 10<sup>th</sup> January, 2023. The HR Plan to include total sanctioned strength, quota against disability already filled, shortfall in observance of Disability Quota, timeframe in which the shortfall shall be filled by each Ministry/Division/Department. The said website to be updated on quarterly basis.
