- 2. Candidates having domiciles of the relevant Region/ Province, under the jurisdiction of the Directorate (s) mentioned above, are eligible to apply against the posts vacant in the desired Directorate (s). Both male and female candidates are eligible to apply.
- 3. Khyber- Pakhtunkhwa includes the merged areas of ex-FATA and ex-PATA.
- 4. Candidates will be required to bring their Original Documents and also, two (02) sets of attested copies thereof, at the time of interview.

- 6. Only the candidates short-listed on the basis of skill tests and physical standards, will be called for test / interview. No TA / DA shall be admissible for appearing in the Test / Interview.
- 7. 10% quota for Women, 5% quota for Minorities and 2% quota for disabled persons (if applicable) will be observed as per government instructions.
