It is to inform that printing of cards of Ali Medical Centre/Hospital (PVT) Ltd. for FBR HQs, and field formations in Islamabad and Rawalpindi are under process and shall be issued by the Welfare Section. However, Ali Medical Centre/Hospital (PVT) Ltd. will entertain/consider the employees of FBR and its field formations on showing their FBR official cards.

# MEMORANDUM OF UNDERSTANDING

This Understanding is made on January, 2023 between Ali Medical Centre (PVT) Ltd. ### And

Federal Board of Revenue" having its Office on Shahrah-e-Dastoor, Islamabad of the other part. Whereas: the Ali Medical Centre (PVT) Ltd. agrees to provide medical services to the FBR for medical treatment of persons pertaining to FBR.

### Whereas:

- The Ali Medical Centre (PVT) Ltd. agrees to provide "Medical Services" to the employees of FBR and its field formation and sub-ordinate offices and their dependents including parents of (the "Employees") and FBR agrees to avail such services subject to this MoU and without any financial liability of FBR as institution; and
- 2. The Parties are now entering into this MoU to set out the understanding between Parties in relation to the provision of services for the serving or retired employees of **FBR**.
- 3. Terms of the MoU:
- 3.1. Entry into Force and Termination.
- 3.2. This MoU shall remain valid from the date of signing and may be discontinued by either party by giving one month's written notice to the other party through the post or by hand delivery.
- 4. Responsibilities of Ali Medical Centre (PVT) Ltd:
- 4.1. The types of medical services which the Ali medical Centre (PVT) Ltd. can provide relating to inpatient/out-patient services have been advised to the FBR by the Ali Medical Centre (PVT) Ltd. along with the discounted charges of such medical services which will be paid by the FBR employees in cash on the spot.
- 4.2. Ali Medical Centre (PVT) Ltd. will provide "Medical Services" to M/s FBR with Flat 15 % discount percentages at all kind of medical treatments/services excluding medicines and consumable items.

- Ali Medical Centre (PVT) Ltd. will print/issue cards for each employee of FBR as provided by 4.3. FBR. Agreed discount mentioned on this card will be provided by Ali Medical Centre (PVT) Ltd. The Ali Medical Centre (PVT) Ltd. will also entertain/consider to the employees of FBR and its field formation and sub-ordinate offices and their dependents including parents (the "Employees") for the discount (as %age mentioned above) on showing their FBR office cards as well. Agreed discount percentage shall be mentioned on printed card of Ali Medical Centre (PVT) Ltd.
- 4.4. There will be no hidden charges in agreed rates.
- 4.5. FBR Employees/Dependents will get priority services from Ali Medical Centre (PVT) Ltd.
- 4.6. Ali Medical Centre (PVT) Ltd. will try its maximum to accommodate patients of the FBR in the appropriate patient room, whose charges would be within the agreed discounted rates.
- 4.7. In case of non-availability of vacant room, Hospital will inform the patient to wait if possible. Otherwise Hospital doesn't guarantee to provide indoor patient room to each and every patient in case of non-availability of vacant inpatient room.
- 4.8. Ali Medical Centre (PVT) Ltd. shall provide the following categories of indoor patient rooms:
  - a) Executive Plus room
  - b) Executive room
  - c) Private room
  - d) Semi-Private room
  - Ward
- 4.9. Ali Medical Centre (PVT) Ltd. will provide the discharge summary to each patient of the FBR.
- 4.10. Ali Medical Centre (PVT) Ltd. will also provide a copy of lab investigation/X-Ray report, when requested.
- 5. Responsibilities of FBR:
- 5.1. FBR shall not be responsible for financial liability of any employee towards Ali Medical Centre (PVT) Ltd. nor shall reimburse any expenditure of any of its employee. All FBR's employees visiting Ali Medical Centre (PVT) Ltd. will be personally liable for any payment towards Ali Medical Centre (PVT) Ltd. and shall pay it in cash.
- 5.2. FBR will provide list of FBR employees to Ali Medical Centre (PVT) Ltd. for printing/issuing of discounted cards for employees of FBR.
