

*"The condition to apply for employment within one year under the Assistance Package as notified by the Establishment Division vide O.M No.8/10/2000-CP-I dated 6<sup>th</sup> August, 2004 and O.M No. 4/1/2005-CP-I dated 13<sup>th</sup> April, 2005. is amended to the extent that: the widow/widower or a child of a civil servant who dies during service may be entitled to apply for contract appointment as per maximum age limit prescribed for Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993"*
