The competent authority to nominate officers for inland/foreign trainings is Member (Admn/HR) as per "Delegation of Administrative Powers" circulated vide Notification C.No.1(14)S(T&D)/2021-161415-R dated 08.10.2021. However, it has been observed with grave concern that officers of FBR (HQ) and its field formations directly apply for the foreign trainings offered through different Ministries/Organizations, without seeking prior approval from the competent authority.

- O2. In this regard, all Members/ Chief Commissioners/ Chief Collectors/ Director Generals are directed to ensure that the officers under their administrative control may comply with the "Delegation of Administrative Powers" dated 08.10.2021 and 01.06.2023 and seek approval from competent authority prior to apply in any training. Non-compliance of the directives will entail to disciplinary proceedings against the respective officer. Delegation of Administrative Powers dated 08.10.2021 dated 01.06.2023 are being circulated once again for strict compliance.

- 2. The field formations shall continue to plan training of its staff within budget allocated to them. For officers nominated by the Board, who apply online, the Board shall bear the cost of trainings. However, TA/DA shall be paid by the respective field formations.
- 3. Nomination of an officer for a course, once finalized, shall not be withdrawn. Failure to join the course shall result into blacklisting of the officer for all future local/foreign trainings besides initiation of disciplinary proceedings against the delinquent officer.

4. The officer of FBR on deputation may apply for foreign scholarships through the current employer under intimation to Admn/HR Wing. However, upon final selection, NOC for proceeding abroad shall be obtained from Admn/HR Wing.
