The Establishment Division has informed that a meeting of High-Powered Selection Board (HPSB) for promotion of officers of Inland Revenue Service from BS-21 to BS-22 posts, is scheduled to be held shortly and cases for promotion shall be submitted to the Establishment Division for HPSB, accordingly. However, your cooperation in timely completion of service record is equally essential.

4. Please note that any officer who fails to furnish the above documents by due date of **20.06.2023**; will himself/herself be responsible for non-consideration / deferment / supersession.
