PROMOTION OF SUPERVISORS/HEAD CLERKS (BS-14) AND ASSISTANT (BS-15) TO THE POST OF OFFICE SUPERINTENDENT (BS-16) IN INLAND REVENUE FIELD FORMATIONS.

I am directed to refer to the above subject and to say that panels of eligible Supervisors/Head Clerks (BS-14) and Assistant (BS-15) have been received from different field formations for consideration of their promotion to the post of Office Superintendent (BS-16) against 90% and 10% respectively. However, it has been observed that some field formations have excluded the names of Supervisors/Head Clerk and Assistants working in the Directorate General of I&I(IR) Islamabad and its regional Directorates/offices at the respective stations, in the light of decision already conveyed by the Board vide letter No.25(30)MIR.IV/2017 dated 01.03.2024 to maintain separate senority list of staff in each cadre (BS-1 to 15 except DEOs) by the Directorate General of I&I(IR) itself.

- 2. Since the Directorate General of I&I(IR) has not yet finalized their separate seniority list of staff on the analogy of Directorate General of Internal Audit(IR), therefore, all staff (BS-1 to 15 except DEOs) of the Directorate General of I&I(IR) including its regional Directorates/offices shall continue to be included in the senority lists of staff being maintained by RTOs/CTOs at the respective stations as before, until and unless the process of issuance of separate seniority lists is finalized by the Directorate General of I&I(IR) as already approved by the Board.
- 3. In view of above, all those field formations, who have forwarded the panels for promotion to the post of Office Superintendent (BS-16), are requested that the following Certificate may invariably be forwarded to the Board <u>within a week positively</u> for consideration of promotion case by the Board:-

"Certified that the panel of Supervisors/Head Clerks and Assistants, earlier sent to the Board, includes all employees of same cadres working in the Directorate General of I&I(IR) or its regional Directorate, at the respective station."

- 4. In case any of the field formation has already forwarded the panel to the Board after exclusion of Supervisors/Head Clerks and Assistants of the Directorate General of I&I(IR) or its regional Directorates at the respective station, the same may please be rectified immediately and furnish a revised panel and seniority list including the staff in these cadres presently working in the Directorate General of I&I(IR) or its regional Directorate/office at the respective station.
- 5. This exercise should be completed with a compliance report to the Board within a week positively.
