O. 894(I)/2024.—In exercise of the powers conferred by sub-section (1) of section 25 of the Civil Servants Act, 1973 (LXXI of 1973) read with Notification No. S.R.O.120(I)/98, dated the 27th day of February, 1998, the Prime Minister is pleased to direct that the following further amendment shall be made in the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, namely:—

In the aforesaid Rules, in rule 4, for sub-rule (2), the following shall be substituted, namely:

“(2) A committee constituted under sub-rule (1) shall consist of a chairperson and not less than two other members, including at least one woman member if available”.
