- B. Websites, names and E-mail addresses of known foreign manufacturers of the item in question through which the actual current value can be ascertained.
- C. Copies of Contracts made / LCs opened during the last three months showing the value of item in question.
- D. Copies of Sales Tax Invoices issued during last four months showing the difference in price (excluding duty and taxes) to substantiate that the benefit of difference in price is passed on to the local buyers.

3. In addition to above you are requested to bring any other relevant document, test report, literature and representative samples and proposed calculations in support of your contention so that the meeting is purposeful and the issue is decided quickly.

4. Your participation is earnestly requested so that your esteemed point of view is considered and a fair customs value is determined.

5. Trade bodies, representative associations and Chambers of Commerce are further requested to circulate this Notice amongst their respective honorable members and invite them on our behalf to attend the meeting for the maximum stakeholder participation.
