02. The meeting for the determination of customs values of subject item under Section 25A of the Customs Act, 1969 is to be held on **10-06-2026** at **12:00 PM** in the office of the Director (Customs Valuation), on 7<sup>th</sup> Floor, Custom House, Karachi.


03. Each participant is requested to kindly bring: -

- i. *Copies of invoices of imports (including GDs, ER, PL, BL, & all related imported documents each GD-wise) during last one year showing factual value.*
- ii. *Websites, names and E-mail addresses of known foreign manufacturers of the item in question through which the actual current value can be ascertained.*
- iii. *Copies of Contracts made / LCs opened during the last one year showing the value of item in question, each GD-wise.*
- iv. *Copies of Sales Tax Invoices issued during last one year showing the difference in price (excluding duty and taxes) to substantiate that the benefit of difference in price is passed on to the local buyers, each GD-wise.*
- v. *Latest price catalogue issued from manufacturer.*
- vi. *Manufacturer's discount schedule if any.*
- vii. *Copies of export GDs of manufacturer.*

04. Other relevant documents like test report, representative samples and proposed working in support your contention so that the meeting is purposeful and the issue is decided quickly.

05. Your participation is earnestly requested so that your esteemed point of view is considered and a fair customs value is determined.
