



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MoU") is made and executed at Lahore on this 19th day of May, 2026.

BETWEEN

FEDERAL BOARD OF REVENUE (FBR), a Federal Government Agency constituted under the Federal Board of Revenue Act, 2007, having its headquarters at G-5/2, Constitution Avenue, Islamabad (hereinafter referred to as the "FBR", which expression shall, where the context so requires, include its permitted assigns, administrators, and successors-in-interest).

AND

DOCTORS HOSPITAL & MEDICAL CENTRE, a company incorporated under the laws of the Islamic Republic of Pakistan, having its registered office at 152-G/1 Canal Bank, Johar Town, Lahore (hereinafter referred to as the "Hospital", which expression shall, where the context so requires, include its permitted assigns, administrators, and successors-in-interest);

(The Hospital and the FBR are hereinafter individually referred to as a "Party" and collectively as the "Parties".)

RECITALS

A. The FBR desires to facilitate access to medical services for its serving and retired employees and their eligible dependents (hereinafter referred to as the "Employees").

B. The Hospital is engaged in providing inpatient, outpatient, diagnostic, imaging, surgical, laboratory, and other allied medical services and has agreed to extend such services to the Employees on cash-discounted terms.

C. The Parties wish to record their mutual understanding regarding the provision of medical services on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants and undertakings contained herein, the Parties hereby agree as follows:

1. SCOPE OF SERVICES

1.1 The Hospital shall provide inpatient, outpatient, imaging, surgical, laboratory, and other allied medical services to the serving and retired Employees of the FBR, including their parents and children.

1.2 All services shall be provided on a cash payment basis, subject to discounted rates as agreed and detailed in Annexure "A".



1.3 The FBR shall not bear any financial or legal liability in respect of medical services availed by any Employee under this MoU.

2. TERM AND TERMINATION

2.1 This MoU shall come into force from the date of signing and shall remain valid unless terminated earlier.

2.2 Either Party may terminate this MoU by giving one (1) month's prior written notice to the other Party, either by registered post or by hand delivery.

3. OBLIGATIONS OF THE HOSPITAL

3.1 The Hospital shall provide medical services at discounted cash rates as specified in Annexure "A".

3.2 The Hospital shall extend the applicable discount to eligible Employees upon:

- Presentation of a valid FBR employee card; or
- Verification through details provided by the FBR.

3.3 No registration fee shall be charged to Employees of the FBR.

3.4 The Hospital shall ensure that:

- There are no hidden or undisclosed charges beyond the agreed rates; and
- All charges are transparent and communicated in advance where possible.

3.5 The Hospital shall provide online access, SMS alerts, and online reporting facilities to enable Employees to view diagnostic and laboratory reports.

4. OBLIGATIONS OF THE FBR

4.1 The FBR shall not be responsible for, nor shall it reimburse, any medical expenses incurred by any Employee at the Hospital.

4.2 All Employees availing medical services under this MoU shall be personally liable for payment of all charges payable to the Hospital.

5. DISPUTE RESOLUTION

5.1 In the event of any dispute or difference arising out of or in connection with this MoU, the same shall be resolved amicably through mutual consultations between the senior management of the Hospital and the FBR.

5.2 The Parties agree that no dispute shall be referred to any court of law.

6. AMENDMENT

6.1 No modification, amendment, or variation of this MoU shall be valid unless made in writing and signed by both Parties.


7. COMMUNICATION AND COORDINATION







