Subject: **DETERMINATION OF CUSTOMS VALUES OF "COCONUT OIL" UNDER SECTION 25A OF THE CUSTOMS ACT, 1969 (IV OF 1969).**

Please refer to the subject noted above.

2. This Directorate has initiated exercise for the determination of customs values of imported "Coconut Oil" under Section 25A of the Customs Act, 1969 with the objective of ensuring fair, transparent, and up-to-date assessment of customs values in line with prevailing international market trends.

3. A stakeholder meeting in this regard has been scheduled on 06-10-2026 at 11:00a.m., in Conference Hall, 7th Floor, Custom House, Karachi. All relevant stakeholders, representatives of trade bodies, and other concerned parties, are invited to attend the meeting. All

stakeholders are also requested to bring their written submissions, duly supported by documentary evidences including:

- a) Import invoices and Goods Declarations (GDs).
- b) Copies of Letters of Credit (LCs) or contracts.
- c) International price or references.
- d) Manufacturer/exporter price lists or catalogues.
- e) Market survey data, if available.
- f) Any other relevant document(s).

4. The purpose of this meeting is to review all relevant market information and trade data to facilitate the determination of customs values in a fair, equitable, and evidence-based manner. Stakeholders' participation and cooperation in providing accurate information and constructive input will assist the Directorate in finalizing of values that reflect prevailing market conditions and maintain transparency in the valuation process. It is, therefore, requested that all concerned stakeholders' ensure their presence in the meeting on the scheduled date and time, along with the relevant documents and written submissions. Non-attendance shall be deemed as having no objection to the proceedings.

5. The trade bodies and representative associations may circulate this meeting notice amongst their respective relevant members for information.
