No. 8/10/2013-E-2 dated 9th February, 2015 including amendments thereof issued from time to time on the subject noted above and to state that the Prime Minister has been pleased to approve the following revised Assistance Package with effect from 28-08-2026, for Government employees who die in service: -

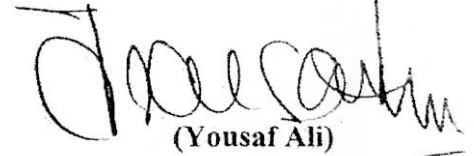

2. A death of a government employee will be deemed to be a "security related death" if it occurs due to an immediate and direct consequence of any act of terrorism, militancy, violent resistance, targeted attack, or hostile action arising from, connected with, or attributable to the discharge of official duties. An incident not attributable to any act of violence or threat arising from the performance of official duties, is not a security related death.

3. The aforesaid package (both in-service and security related deaths) is applicable *mutatis-mutandis* to all regular federal government employees who die in service on or after the date of its issuance and shall supersede all the previous Assistance / Shuhada Package(s) issued by this Division.
