**(CUSTOMS)**

S.R.O. 967 (I)/2007.- In exercise of the powers conferred by section 3 of the Customs Act, 1969 (IV of 1969), sections 30 and 31 of the Sales Tax Act, 1990 and in supersession of its Notification No. S.R.O 41(I)/2000, dated the 1<sup>st</sup> February, 2000, the Central Board of Revenue is pleased to appoint—
