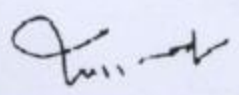
NOTIFICATION**COLLECTORS OF CUSTOMS (APPEALS)**

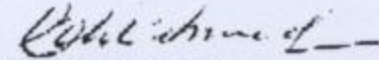
