S.R.O. 555 (I)/2017.- In exercise of the powers conferred by sub-section (3) of section 18 of the Customs Act, 1969 (IV of 1969), the Board, with approval of the Federal Minister-in-charge, is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O.568(I)/2014 dated the 26th June, 2014, namely:-

2. In the aforesaid Notification,-

(1) in the Table, in column (1),-

(g) after serial number 399, and entries relating thereto in columns (2),(3) and (4), the following new serial number and the entries relating thereto in columns (2),(3) and (4) shall be inserted, namely:-

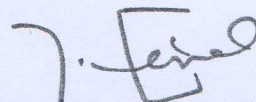
- (h) for S.No.420 and entries relating thereto in columns (2), (3) and (4), the following shall be substituted, namely:-

- (2) in paragraph 2, for clause (c), the following shall be substituted, namely;-

"(c) imports under Fifth Schedule to the Customs Act, 1969 (IV of 1969), excluding serial number 9B,9C,9D,84 and 85 of the Table of Part-III, serial numbers 1,10 to 15 and 17 to 24 of Table-B, of Part VII of the said Schedule subject to fulfillment of conditions laid therein;"
