2. The method of appointment to the post shall be as under:—

Note the posts in BS-17 up-graded to BS-18 and shall stand abolished on promotion of existing incumbent in BS-17.

CONDITIONS FOR PROMOTION

3. Promotion to the posts in column 2 below shall be made by selection from amongst the persons who hold the posts specified in column 3 on a regular basis and fulfill the conditions of eligibility as prescribed in column 4:

4. Persons appointed by promotion or transfer shall be on probation in accordance with the provisions of Section 6 of the Civil Servants Act, 1973 read with Rule-21 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.
