2. The Deputy Director (Licensing), SECDIV shall act as the Secretary in the absence of Director (Licensing and Regulations).

3. The main functions of the LRC shall be —

- (a) assess or review or evaluate license applications referred to LRC members by SECDIV and provide recommendations and institutional input for approval or denial by DG SECDIV. Recommendation and institutional input must be provided timely within twenty days of the receipt of the case;

- (b) apart from special meetings on specific license application or related issues, hold routine quarterly meetings;
- (c) assess or review the existing licensing system and provide input for further streamlining and improving the mechanism;
- (d) liaison and coordination for reducing processing time of license applications; and
- (e) act as a standing forum for exchange of information and sharing views on implementation of strategic export controls in general and licensing matters in particular.
