S.R.O. 2301(I)/2022.- In exercise of the powers conferred by section 3 of the Customs Act, 1969 (IV of 1969), sections 30 and 31 of the Sales Tax Act, 1990 and in supersession of its Notification No. S.R.O 624(I)/2021, dated the 28th May, 2021, the Federal Board of Revenue is pleased to appoint—

 - (iii) Clearance of Accompanied and Unaccompanied Baggage at Bacha Khan International Airport and Land customs Stations of civil divisions of Peshawar, Mardan and Malakand;
 - (iv) Postal appraisalment at GPO, Peshawar;
 - (v) Investigation & Prosecution Branch;
 - (vi) Auction and destruction of goods;
 - (vii) All matters relating to warehouses owned and operated by airlines and state warehouses within the territorial limits of the civil divisions of Peshawar, Mardan and Malakand;
 - (viii) Central repository of all services related to record of staff;
 - (ix) Matters related to Custom House Peshawar i.e. security, allotment of residential accommodation, construction, change in building structure, horticulture or Custom House Library; and
 - (x) monitoring of gates of dry ports and border customs-station including gate-in and gate-out of the imports and exports cargo and all allied matters excluding matters related to transit trade.
30. Customs Enforcement School (CES), Peshawar.
- (i) Training of officers, executive staff and Sepoys
 - (ii) Preparation of Customs Contingent for National events.
 - (iii) Conducting regular enforcement training cycles for all ranks upto BS-19 for all Customs formations.
 - (iv) Maintenance of training record of officers & staff BS-05 to 19 stationed in all Customs formations.
 - (v) Establishment of Academy-to-Academy training collaboration with national and regional institutions.
 - (vi) Development of enforcement methodologies and training modules.
 - (vii) Review of international enforcement related developments for capacity building of Pakistan Customs; and
 - (viii) Maintenance and upgradation of Central Armoury at Custom House, Peshawar.
31. Collector, Collectorate of Customs Enforcement, Dera Ismail Khan.
- (i) All Anti-smuggling and Preventive operations including the field units i.e. Mobile Squad/check posts located within Civil Divisions of Dera Ismail Khan, Bannu and Kohat;
 - (ii) All matters of customs including imports and exports at D.I. Khan and Bannu airports;
 - (iii) Postal appraisalment at GPO, D.I Khan;
 - (iv) Investigation & Prosecution Branch;
 - (v) Auction and destruction of goods;
 - (vi) All matters relating to warehouses owned and operated by airlines and state warehouses within the aforesaid Civil divisions at S.No (i) above; and
 - (vii) Monitoring of gates of dry ports and border customs-station including gate-in and gate-out of the imports and exports cargo and all allied matters excluding matters related to transit trade.

32. Collector, Collectorate of Customs, Islamabad. All matters of Customs including cargo clearances for imports, exports and temporary imports (excluding transit), warehousing of goods, licensing of warehouses and clearing agents, issuance of user-IDs for WeBOC users excluding government agencies, auctions, DTRE, manufacturing Warehouses (Open Bond Schemes), Manufacturing Bonds, Export Oriented Units and anti-smuggling operations in the Civil Division of Rawalpindi (Punjab) and the Islamabad Capital Territory, including the following Customs-stations, namely:

 - (ii) Monitoring of Air Freight Unit at Islamabad International Airport (IIAP);
 - (iii) Passenger traffic and handling of crew at IIAP;
 - (iv) Accompanied and Unaccompanied baggage of passengers and crew;
 - (v) Monitoring of airports and terminal gates;
 - (vi) Sealing and de-sealing of air shipments;
 - (vii) Ground handling agents;
 - (viii) warehouses owned and operated by airlines and duty free shops;
 - (ix) Postal appraisalment at GPO, Islamabad and GPO, Rawalpindi;
 - (x) Anti-smuggling and Drug Enforcement Functions at IIAP;
 - (xi) Air Cargo Control Unit (ACCU); and
 - (xii) Aircraft clearance, Boarding and Rummaging.
34. Collector, Collectorate of Customs Sambrial, Sialkot. All matters of Customs including cargo clearances for imports, exports and temporary imports (excluding transit), warehousing of goods, licensing of warehouses and clearing agents, issuance of user-IDs for WeBOC users excluding government agencies, auctions, DTRE, manufacturing Warehouses (Open Bond Schemes), Manufacturing Bonds, Export Oriented Units and anti-smuggling operations, within the territorial limits of the Civil Division of Gujranwala, including the following customs stations, namely:-
- (i) the customs-port at Sambrial, Sialkot;
 - (ii) Sialkot International Container Terminal;
 - (iii) Duty free shops, Sialkot;
 - (iv) General Post Office, Sialkot;
 - (v) Customs-airport at Sambrial, Sialkot; and
 - (vi) Kartarpur Border Terminal.
35. Collector, Collectorate of Customs, Gilgit-Baltistan. All matters of Customs including cargo clearances for imports, exports and temporary imports, transit, warehousing of goods, licensing of warehouses and clearing agents, issuance of user-IDs for WeBOC users excluding government agencies, auctions, DTRE, manufacturing Warehouses (Open Bond Schemes), Manufacturing Bonds, Export Oriented Units and anti-smuggling operations within the territorial limits of the Districts of Gilgit,

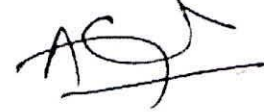
Skardu, Ghanche, Astore, Diamir, Hunza-Nagar and Gilgit (Gilgit-Baltistan), including the following, namely:

- (i) the Gilgit customs-station;
- (ii) the Sost and Dih customs-station; and
- (iii) Silk Route Dry Port, Sost.

2. The warehousing of goods shall be in those areas within the territorial limits mentioned against Collectorates, which have been notified as warehousing stations under section 11 of the Customs Act, 1969.

3. This notification shall take effect from the 15th January, 2023.
