S.R.O.157(I)/2022.- In exercise of the powers conferred by sub-section (3) of section 18 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O. 840(1)/2021, dated the 30th June, 2021, namely: -

2. In the aforesaid Notification, in the Table, in column (1), -

- (i) after S. No. 136 and the entries relating thereto in columns (2), (3) and (4), the following new serial number and the corresponding entries relating thereto in columns (2), (3) and (4), shall be inserted, namely: -

- (iv) after S. No. 207 and the entries relating thereto in columns (2), (3) and (4), the following new serial numbers and the corresponding entries relating thereto in columns (2), (3) and (4), shall be inserted, namely: -

207B	5506.4000	Of polypropylene	10";

- (v) after S. No. 543 and the entries relating thereto in columns (2), (3) and (4), the following new serial number and the corresponding entries relating thereto in columns (2), (3) and (4), shall be inserted, namely: -

"543A	8703.8090	Electrical vehicles (EVs) in CBU condition of more than 50 KWH battery pack excluding commercial buses and trucks (upto the 30th June, 2022)	10";

- (vi) against each of S.Nos.496, 497, 498, 499, 500, 501, 502, 503, 504, 511, 512, and 513, in column (4), for the figure "15", the figure "50", shall be substituted upto the 30th June, 2022; and

- (vii) against each of S. Nos. 525, 530, 536 and 541, in column (4) for the figure "15", the figure "50", shall be substituted upto the 30th June, 2022.
