TERMS & CONDITIONS

- 1. The tender shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- 2. The bidders should be registered with Income Tax and Sales Tax Departments, having their own office & phone / tax numbers (if found contrary the tender will be rejected).
- The bidders should not be black-listed by any authority in the past.
- Bidders are required to furnish Security Deposit 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favour of the Chief Commissioner, Regional Tax Office, Sukkur. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- 5. Sealed tender bids on prescribed tender document must be delivered to the address given below on 15-05-2012 before 02:00 pm and shall be opened at 03:00 pm on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
- 6. The Chief Commissioner, Regional Tax Office, Sukkur may reject or accept any offer or ask for any amendment in the specifications / offer or reduce or enhance the quantity of items meant for purchase, without assigning any reason.





- 7. Bidders shall quote their final prices both in figures and in words on free delivery basis, any cutting / overwriting and correction in the tender form will not be accepted.
- 8. Bidders are required to give complete sample at the time of bidding.
- 9. All Government taxes will be deducted as per laws / rules.
- 10. The bidder should enclose a copy each of NTN Certificates, Sales Tax Registration Certificates and CNIC of the proprietor.
- 11. Incomplete tender will not be accepted in any case.
- 12. The Purchase Committee, Regional Tax Office, Sukkur reserves the right to cancel any or all bids either in whole or in part as per rule.
- 13. Successful bidders have to supply items as per work order within 15 working days.
- 14. The bids shall remain valid for the work orders to be issued upto 30-06-2012.
- 15. The payment will be made on the supply of items and clearance of bills from District Accounts Office, Sukkur.
