**2. Terms and Conditions:**

1. Tenders are required to quote price for one year subscription.
  2. The price offer will include all duty & taxes and expenses incurred on supplies.
  3. The price will be quoted in local currency i.e. Pak Rupees.
  4. Tenders shall guarantee for one year un-interrupted supply of the Magazine/ Journal/ Web Site for which tender has been accepted.
  5. The tenders are required to furnish 2% of the total amount as earnest in the shape of Pay Order or Demand Draft from a scheduled bank in favour of the Collector of Customs, Appraisalment, Custom House, Karachi.
  6. The tenders are required to provide sales tax registration & NTN certificate.
  7. The tenders shall specify the period from the date of acceptance of tender within which the supply of magazine shall be started.
